Houston Housing Remains on Track for a Record Year

HAR will release **September 2021** MLS statistics this Wednesday. Here is a sneak-peek at some of the key takeaways from the latest **HAR Market Update**:

- September housing indicators held to positive territory heading toward the final quarter of 2021.
 Single-family home sales rose 1.5 percent. On a year-to-date basis, sales are running 15.3 percent ahead of last year's record pace.
- The single-family average price rose 13.4 percent to \$372,408 and the median price climbed 13.3 percent to \$300,000. Pricing continues to moderate since reaching record highs in June;



- Inventory dropped from a 2.4-months supply to 1.8 months which, while down, is the highest level of 2021.
- Townhome and condominium sales increased 11.7 percent with the average price up 12.1 percent to \$240,994 and the median price up 17.6 percent to \$210,000;
- Leases of single-family homes fell 8.2 percent while townhome and condominium leases dipped 1.8 percent.

Important NAR Code of Ethics Update: TREC Legal II No Longer Qualifies!

The TREC Legal II course required to renew your license no longer satisfies the NAR requirement for REALTOR® Code of Ethics training.

*If your agents took TREC Legal Update II in 2019, you have fulfilled the COE requirement for the current cycle.

*If your agents took TREC Legal Update II anytime after 2019, they must complete NAR-approved COE training before December 31, 2021 (if they haven't already done so).
