## Take a FRESH Look at Houston Housing



#### **New Listings ★**3.2% 9,236 while remaining sluggish in urban areas. REALTORS® entered 9,236 properties into the Multiple Listing Service (MLS) in November versus 8,951 a year earlier. That translates to an overall increase of 3.2 percent.

### Check out HAR's **November 2021** FRESH (First Real Estate Snapshot of Houston)!

- November delivered a mixed bag of housing news for the greater Houston market.
- **New Listings** registered a 3.2 percent overall increase versus November 2020, with the strongest activity in suburban and rural submarkets.
- Active Listings fell 17.4 percent compared to November of last year, as sales volume continued to outpace the entry of new listings to the marketplace.
- Average List Price for homes across greater Houston rose 11.1 percent year-over-year to \$390,401. That figure remains below the record of \$399,510 reached in June of 2021.
